# Balogun & Dawodu Accused Of Theft

An interesting case of how two friends Messrs Balogun and Dawodu duped a popular business man in Lagos came up before Magistrate Ayo Williams at the Sant Anna Court No 1 on Tuesday, December 12, 1950.

The case as outlined by the Police was that during October 24th to 26th 1950, the accused persons jointly stole from Mr Shittu Sumonu of 20 Freeto Lane Lagos, 9 cases of Aluminium Wares value £447.5.5d.

Messrs Dossumu and Adefarasin appeared for the accused persons, while Mr G.B.A. Coltz watched brief for the complainant.

At the resumption of the case the first witness for the Police was the complainant. He disposed how he approached the two accused persons in October 1950 for a loan of £185, to buy duty on certain goods which he ordered from England, and made application for the goods to be used as exhibit. The two persons asked him to sign a promissory note of £280 on the 4th of November 1950.

The Complainant said in view of this understanding he kept the 9 cases Aluminium wares in the store of the accused person but when on 5th November 1950, he sent order to withdraw his goods, his clerk was told by the accused person that the goods were not yet in the store, he went himself to ask for the goods and he was told the same thing.

As the complainant could not understand the change of attitude he made private investigation and later discovered that his goods had been sold to one Nduvatu Aduly of 55 Kasky Street Lagos for the sum of £214.16/-.

As a result of this the Complainant made a report to the Police, Madam Nasrati was instructed in the open Court as the woman with whom the stolen goods were transferred. After this witness the Police made application that few samples of the goods be used as exhibit.

The case was at this juncture adjourned till December 25 1950.

# Lagos Electricity Undertaking

There has been some improvement in the generating capacity of the power station and in distribution in certain areas supplied by the Lagos Electricity Undertaking, and it has been found possible to exist temporarily certain of the restrictions now imposed.

These relaxations cannot for technical reasons be applied to the undertaking as a whole as many substations are already working under overland conditions. It will be possible, however, only to accept new applications for the supply of electricity in certain areas at present, and it is hoped to include other areas from time to time. Applications already received, and for which supply has now become possible, will be dealt with in strict rotation as will be any new applications.

Consumers granted a day-time supply must continue to observe the limiting period. New applications for day-time supply must guarantee to observe these restrictions.

Installation of domestic appliances (coolers, water heaters, etc.) will be restricted. Consumers who already have these appliances must switch off during the peak period of 10.30 am. to 4.30 pm.
