Mr. E. O. Amosaka (Ikorodu), Mr. P. I. Ngechane (Oshisha), Mr. J. T. W. Pepple (Ushishi), and Mr. J. A. Umoh (Port Harcourt), have all been promoted to Management Status with effect from the 1st of January, 1958.

Mr. E. O. Amosaka, who comes from Akoka, was educated at St. Mary's School at Port Harcourt and after leaving school became a Teacher until he joined U. A. C. as a Clerk in the Finance Department at Calabar on the 1st of April, 1951. After working for two years in the Hardware Department, he was promoted Grade Two Sales Assistant on the 1st of January, 1956.

he was promoted Grade One Sales Assistant at Ikorodu and a year later was transferred to Enugu where he is still employed.

Mr. P. I. Ngechane comes from Abaya Town and was educated at Abaya Baptist Catholic School.
