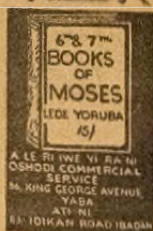

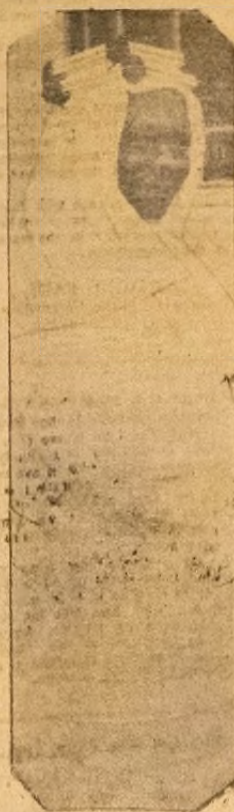

Electricity Corporation of Nigeria Public Notice

Wiring Of Premises For A Supply Of Electricity.

Prospective consumers who are contemplating having their premises wired for connection to the public electricity supply and existing consumers who wish to extend their wiring installation are advised that the Electricity Corporation may decline to connect any installation which has been wired or extended without full compliance with Regulation 203 of the Electrical Supply Regulations.

The provisions of Regulation 203 are as follows:-

203. (1) For the purpose of ensuring that the requirements of the Electrical Supply Regulations and of the Electrical Wiring Regulations are being complied with, the Electricity Corporation of Nigeria shall require every consumer and/or prospective consumer to serve upon the Corporation notice of:-

(a) the consumer's intention to instal or have installed electric lines, wires, fittings, apparatus and appliances on any premises;

(b) the consumer's intention to make or have made any additions or alterations to his present installations.

(2) The consumer shall render the Electricity Corporation of Nigeria every reasonable facility for inspecting and testing such electric lines, wires, fittings, apparatus and appliances during the progress of the work and on its completion.

In giving notice of the necessity for compliance with Regulation 203, the Electricity Corporation wishes to point out that such compliance is not only legally necessary but is in the mutual interest of the Consumer and of the Corporation.

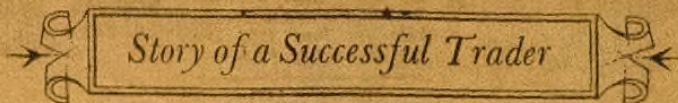

International Telephone Service Extension To Enugu and Kaduna

The Ministry of Communications and Aviation announces that the international telephone Service formerly restricted to Lagos and Ibadan, has now been extended also to all telephone subscribers in Enugu and Kaduna. Subscribers in any of these towns may now book international calls by asking the local operator for "International Service."

In all cases the minimum charge will be for a call of three minutes. A call of that duration to the United Kingdom would cost £3, and to the United States, Canada or Australia, £5. 15/- Further details about the charges to other countries are given in the preface to the Telephone Directory, there will be no necessity for deposits to be paid and the fees for international calls will be added to Subscribers' ordinary telephone accounts.
