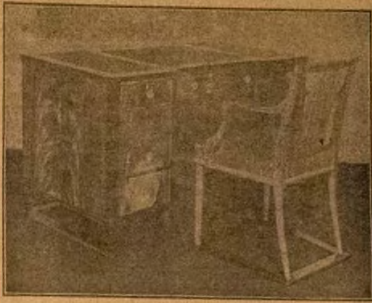

Chief J. K. Randle was a big attraction at today's Melbourne Cup, the glamour event in Australian horse racing.
