That in this connection we had several interviews with the Prince, at which we humbly supplicated him for pardon on behalf of the deposed Chief.

That the Prince ultimately expressed himself in as follows, that the Government is his main supporter and protector from the date of his appointment as the Head of the Royal Family of Lagos till to-day, and seriously considering the timely assistance rendered to him whereby the defiant propensity of the deposed Chief was effectively curbed and a serious crisis averted, he feels powerless to yield to our untiring request for reconciliation but consented to approach the Government in the matter and that the reconciliation depends solely on the Government's consideration. Hence the need of hereby most humbly
