Agbejoro Ogbeni Blackhall, Solicitor General (Acting) Agbejoro Oba tenu bo ọrọ o bere si fesi. The deposition, not ordered. The learned Counsel refers to Rex versus Halliday he said further that if the Officer Administering the Government acted *intra vires* he is protected, but on the face of your Honour's judgment in the first Motion the Officers acted *intra vires* not *ultra vires*. The amendment on the writ of summons cannot at this stage lie, if the action of the Plaintiff is dismissed they can bring a fresh action. Mr. Baddeley's Order did not imply that if the Plaintiff did not go he will do certain thing.

Adajo ni:—Court says: I fine you £50 in default 6 months: in an Appeal you go against fine, but imprisonment is consequential Order as there is a warrant to that.

Solicitor General. Messrs. Baddeley and Thomas have no power to send any one to imprisonment he (the 1st Defendant) made to Order not as Mr. Baddeley (in his private capacity.)

I am refering to Persia Steamship Company versus McClay IKB 1920. The Court held in the judgment on the first Motion that Mr. Baddeley acted on power delegated to him.

Lawyer Thompson:—I am sorry to interrupt. The Court held in the written judgment that the Motion is dismissed that there is no writ of *actio* in the Court.

Court:—Yes.

Court. Versus Solicitor General. I am now sitting on the bench my judgment cannot be cited to me, had it been Justice Vander Meulen, he will be bound by my judgment. I will understand you under sect 2 but there is no privacy in Native Law and Custom.

Solicitor General:—I am referring to 2KB 1910 P 576. No attempt by the learned Counsel to prove any claim against the 2nd defendant Mr. T. S. Thomas The Acting Chief Secretary to the Government.

Adjourned till Thursday 27th instant.

Oloja A. D. A. MacGregor The Acting Attorney General continued:—To the question of 2nd defendant there is no claim against him in the writ of summons. 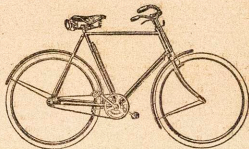
