### STATED CASE.

REX *versus* JOSHUA ABIODUN LEIGH

After an able argument by the Counsel for Appellant. The Judge found no ground to consider the point of law submitted by the counsel for the Appellant. Therefore the case was missed with £5 5 0. Costs to the respondent.

In the matter of an order under the hand of the Officer Administering the Government dated the 1st day of August 1925, and also an order under the hand of the Officer and seal of the Colony and Protectorate of Nigeria dated the 8th day of August 1925, under the deposed Chief Resident Ordinance Chap 78 Sect. 2 concerning Eshugbaya Eleko.

Motion by Joseph Egerton Shyngle.

Shyngle:—I appear to move with my learned friends Messrs. Ayo Williams, W. Williams and J. C. Zizer.

Shyngle:—I am asking for leave to serve notice, and further leave to serve Mr. R. H. Lape District Officer, Oyo. I am asking for leave to serve the District Officer, Oyo because it is outside the jurisdiction and also leave to serve the Officer Administering the Government. See page 43 of the Supreme Court Ordinance Vol. 3.

I withdraw the application for leave to serve Lape but to serve the Officer, Administering the Government because he is the only one that can give Order for his release.

Court:—Leave granted to serve the Officer Administering the Government.  
Motion adjourned till Thursday the 24th instant.

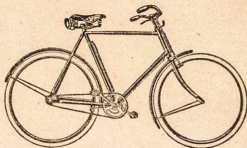
