Contract for Sewage Disposal

TENDERERS are hereby invited for the clearance of Nightsoil in each of the following zones of Lagos:

ZONE 1 Western Portion of Lagos Island comprising Municipal Wards 'A' East, 'A' West 'B' East and 'B' West.

ZONE 2 The Eastern Portion of Lagos Island comprising Municipal Wards 'C' East 'C' West, 'W' South and Benji and the Victoria Beach Area of Municipal Ward 'G'

ZONE 3 Lagos Mainland and Iddo Island comprising Municipal Wards 'D' 'E' East, 'E' West 'F' North and 'F' South.

CONDITIONS OF CONTRACT
Tenders must provide for the clearance of Nightsoil in accordance with the following conditions:

1. (a) In Zones 1 and 2, all sanitary pails in these Zones (including those in public latrines) totalling approximately 5,000 pails in each case, must be cleared.

(b) In Zone 3 all sanitary pails (including those in public latrines) which are at present serviced by the Council, totalling approximately 1,250 pails, must be cleared.

2. All sanitary pails must be emptied and cleared daily and the nightsoil therefrom must be removed by the Contractors to the Council's depots or to a specified tipping point on the foreshore.

3. The transportation of nightsoil from the Council's depots to the foreshore will be the responsibility of the Council, but the contractors will be required to tip nightsoil at the foreshore where no depots are provided.

4. Clearance of all pails must be carried out daily and the contractor will provide for a penalty of five shillings per day which will be strictly enforced in respect of every pail not cleared.

5. Contractors must provide a labour force consisting of at least one labourer for every 40 pails to be cleared and a literate headman to be in charge of a maximum of 360 pails. The headman will be required to inspect personally every day all premises from which pails are cleared.

6. Contractors must provide drums for the collection of the nightsoil.

PROVISION OF BOND

Contractors will be required to enter into a bond with the Council for payment in the event of default, of an amount equal to ten per cent of the value of the contract for a period of six months, and tenders tendering must submit with their tenders the names of two substantial bondsmen who are willing to become bound with them for the due performance of the work.

METHOD OF TENDERING

1. Personal tendering must quote the amount to be charged per pail per month for the clearance of nightsoil in accordance with the conditions set out above.

2. Separate tenders must be submitted for each of the three zones.

3. ALL TENDERS must be enclosed in sealed envelopes endorsed outside "TENDER FOR SEWAGE DISPOSAL" and must be addressed to the Town Clerk, so as to reach him not later than 2 p.m. on Tuesday, 24th March 1959.

4. The Council is not bound to accept the lowest or any tender.

PUBLIC WARNING

PLANNING CONTROL

It has come to the Board's notice that in spite of regular public warning by the Board, Land is being sold and purchased for building purposes in Lagos Township (especially in certain parts of Sard Lere and East of Yaba), without previous consultation with the Board's Town Planning Department for information as to how the land or plan for building on them are affected by town planning proposals.

The Board has been further concerned to find that buildings which do not comply with the building Bye-Laws or conform with plans approved by the Board are, in fact, erected on such lands.

Before proceeding to divide any land within the Township in lots for the purpose of sale or building upon, an owner must, by law, first submit two identical plans of the land to the Board for approval.

These plans must show the proposed division of the land into lots and whatever provision if any, has been made for roads.

The public should be aware that unauthorised building within Lagos Township is liable to heavy penalties, including total demolition of the unauthorised building together with fines and/or imprisonment. It is therefore in the interest of intending purchasers of land for building purposes as well as owners of property wishing to alter buildings or rebuild in Lagos Township, that before purchasing land or buildings and before preparing any building plans, they should first consult the Town Planning Department of the Board for necessary guidance.

Inquiries should be made in writing to the Chief Executive Officer or by visit to the Town Planning Department, Lagos Executive Development Board, Reclamation Road, Lagos between the hours of 8 a.m. and 10 a.m. Monday to Friday and 8 a.m. to 9 a.m. on Saturday.
