## PUBLIC NOTICE.

### Pilgrimage To Mecca And The Holy Places In 1962

In view of the increasing difficulties encountered by many Nigerians on holy pilgrimage to Mecca, the Federal Government has decided to introduce some measures to minimise the hardship of pilgrims. These measures have been agreed upon after discussion and consultation with the Governments of the Kingdom of Saudi Arabia and of other countries through which Nigeria pilgrim travel on their way to Mecca and the Holy places.

2. It is therefore notified for general information that, with effect from this year's pilgrimage, travel certificates will no longer be valid for travel to the Sudan and Saudi Arabia and that Nigerian passports will be required for pilgrims proceeding to Mecca. For this purpose special PILGRIM PASSPORTS will be issued. These passports will be valid only until the 31st of July or for six months from the date of issue.

3. A special form of application for pilgrim passports will be available at the Passport Offices in Lagos, Kano and Maiduguri. These forms will also be available at all Provincial and Divisional Administrative Offices and the offices of all Superior Police Officers. In the Northern and Western Regions, supplies will also be obtainable from all Native and Local Authority Offices. Any intending pilgrim who cannot produce proof in the normal manner that one of his parents or grandparents is a Nigerian citizen may obtain a certificate from the Native or Local Authority of his place of birth for this purpose.

4. Applicants for pilgrim passports may be required to undergo a medical test of fitness with a view to eliminating the aged and infirm, pregnant women and young children. Applicants will also be required to produce the following health documents showing evidence of:

- (a) Vaccination against Small pox.
- (b) Inoculation against yellow fever.
- (c) Inoculation against Cholera.
- (d) Inoculation against the ENTERIC Group of diseases (T.A.B.).

The aforementioned documents are available at all hospitals and health centres.

5. The following financial conditions must be met before applicants are granted pilgrim passports:-

#### (A) Air Pilgrims:

- (i) Pilgrims travelling by air must produce a return air ticket for direct flight between Nigeria and Saudi Arabia.
- (ii) They must also possess a substantial amount of money for necessary general expenses in Saudi Arabia. Travellers' cheques for as much money as the pilgrim intends to take with him, but for not more than £200, must be shown at the Pilgrims' Passport Office.

(iii) Air pilgrims are warned that they have certain fees such as Mutsawif, Madinatul Hajjaj, etc., to pay to the Saudi Arabian Authorities. These fees, which total about £28, are included in the amount held in travellers' cheques.

#### (B) Land Pilgrims:

- (i) Any pilgrims travelling by the land-and sea route must pay a deposit of £150 in favour of the Federal Government. This deposit will be used to offset any expenses incurred by Government in repatriating the pilgrim, should it become necessary. The deposit can be paid at any of the branches of the following banks:-

Barclays Bank, D. C. O.

Bank of the North

Bank of West Africa

African Continental Bank

National Bank.

The deposit will be refunded in full at the end of the pilgrimage if there are no claims against the pilgrim.

- (ii) They must also show that they are in possession of travellers' cheques for at least £150. This amount will be required by the pilgrim for necessary expenses on the journey for subsistence, accommodation, transport, etc.

- (iii) Of this amount obtained in travellers' cheques, £7 will be required for fees in the Sudan, £13 for Mutsawif and other fees in Saudi Arabia and £12 for the journey Jeddah-Mecca-Medina-Jeddah.

- (iv) Land pilgrims are advised at the same time as they purchase travellers' cheques, to obtain from the Banks the amount of £10 in Sudanese currency for their immediate expenses on arrival in the Sudan. This sum of 10 Sudanese pounds is additional to the amount to be taken in travellers' cheques.

- 6. These new conditions are in no way intended to restrict the freedom of movement of such citizens as are desirous of performing the pilgrimage. They are necessary to prevent the excessive hardship falling on a large number of Nigerian pilgrims abroad who have hitherto set out on pilgrimage without adequate preparation.
