

The Fiscal Commission.

The Fiscal Commission returned to the United Kingdom on the 16th November, 1957, after a preliminary tour in Nigeria during which the Commission visited the Federal Capital and the capitals of the Empress and the Southern

The Commission will return to Nigeria in late March, 1958, for a period of some six weeks, and will be preceded by January by the Auditor on Indirect Taxation. All persons interested in taxation, wishing to make representations to the Fiscal Commission are invited to submit them in writing by memorandum (six copies of each) to the Joint Secretaries, Fiscal Commission, Governor-General's Office, Lagos. Memoranda should reach this address by the 31st December, 1957. They should only deal with matters fall-
ing within the terms of reference of the Fiscal Commission, which are set out in paragraph 57 of the Report by the Native Constitutional Conference, 1957, (obtainable from the Federal Government Printer, price 1s. Od).

- (a) The exercise of the powers to levy
Income Tax, Direct Taxes and Indirect
Taxes between the Governments of the Federation,
and the appropriate distribution of the revenue from
such taxes between the Federal and Regional
Governments.
- (b) The fiscal arrangements most appropriate for the
future Constitution.
- (c) The structure of government arrangements for
the administration of local politics, Governmental functions
and local taxation.

Under the terms of reference the Commission cannot
say anything of the possibility of the establishment of a
new State as a result of the recommendations of the
Fiscal Commission. It is, therefore, precluded from con-
sidering any representations which concern the establishment of
any such new State.

In considering the memoranda which are submitted, the
Fiscal Commission will decide whether it wishes to hear
from any of those who have submitted written
memoranda.

All memoranda should bear the name and address of the
writer.

Procedure To Be Followed By The Minorities Commission

To give the fullest opportunity for the expression
of opinion on the issues before it the Minorities
Commission will normally sit in public. The Commission
will also, at their discretion, hear evidence and hold
informal discussions in private. While the Commission
wishes to hear all shades of opinion on the matters at
issue, it will not be practicable for them to hear
separately the very large number of individuals who
have asked to be heard. They therefore ask that persons
with similar views should select common spokesmen for
those views. By this means they hope to be able to
inform themselves of all views relevant to their
enquiry. Counsel may present a case if this is desired
but no cross-examination will be permitted.

After a short initial stay in Lagos, the Commissioners
present intention is to visit and hear evidence in the
Regions in the following order:

- (1) Western Region
- (2) Lagos
- (3) Eastern Region
- (4) Northern Region.

Details of the Commission's programme in each Region
will be given from time to time by public notice.


