



In accordance with the Elections (House of Representatives) (Lagos) Regulations, 1954, I hereby appoint H. N. Harcourt, Esquire, Senior District Officer, Lagos, to be Electoral Officer in respect in respect of the Electoral Districts of both Lagos West and Lagos East.

2. In accordance with regulation 5 the date for the publication of the Preliminary List shall be Monday 16th October, 1954.

3. The date for the commencement of the revision of the Preliminary List shall be Monday 1st November, 1954.

4. The date for the holding of the election shall be Friday, 10th December, 1954, and notice of time and place for delivery of nominations will be given later.

Under the Nigeria (Constitution) Order in Council, 1954, Lagos will elect two Representative Members to the House of Representatives. The township has, by the Elections (House of Representatives) (Lagos) Regulations, 1954, been divided into two electoral districts, Lagos West and Lagos East. Each electoral district will elect one Representative Member.

2. The elections will be held on Friday, 10th December, 1954.

3. Lagos West comprises the area contained within the following Wards, as estimated under the Lagos Local Government Law, 1953:

A1, A2, A3, A4, A5, A6  
D1, D2, D3,  
E1, E2, E3, E4, E5, E6,  
F1, F2, F3, F4, F5, F6.

Lagos East comprises the area contained within the following Wards:

B1, B2, B3, B4, B5, B6,  
C1, C2, C3, C4, C5,  
G1, G2, G3,  
H1, H2, H3, H4, H5, H6.

4. The actual areas each Ward will be specified in notices to be displayed in each Ward.

5. The Chief Electoral Officer is the Chief Administrative Officer, Lagos, whose office is in the old Colony Office, Broad Street.

6. The Chief Electoral Officer has, under regulation 5 (a) appointed Monday, 18th October as the date for the publication of the preliminary list of electors.

7. On 18th October, Electoral Officer appointed by the Chief Electoral Officer for each of the two electoral districts will have one copy of the part of the preliminary list relating to each Ward published in the Ward in a convenient place.

8. Each list will be in two parts:

(1) Persons believed to be entitled to vote by reason of a qualification of residence in the electoral district and to be resident in that Ward on the qualifying date.

(2) Persons believed to be entitled to vote by reason of a qualification as a native of the electoral district.

9. Persons entitled to be registered as electors are those persons that are either under any acknowledgement of allegiance to a foreign state, nor after being sentenced within any part of Her Majesty's territories to a term of imprisonment over six months have not completed such sentence nor have been absolved to be Junctures.

(10) On the day fixing date, i.e. 18th October, are British subjects or British protected persons aged 21 years or more, and

(11) Either have been resident in the electoral district for a continuous period of at least 12 months immediately before 18th October or are natives of the particular electoral district.

10. A copy of the preliminary list will be available for inspection by the public from 8 a.m. to 2 p.m. from Monday to Friday and from 8 a.m. to noon on Saturday during the 14 days, 18th-31st October, at the Office of the Electoral Officer in the old Colony Office, Broad Street.

11. By regulation 9(1) any person qualified to vote whose name is omitted or inaccurately stated in the preliminary list may, within the 14 days following the publication of the list, i.e. from 18 to 31st October, by notice in writing to the Electoral Officer on a form obtained at the office of the Electoral Officer claim to have his name and address inserted in list or to have the entry corrected.

12. Likewise, by regulation 9(2) any person qualified to vote whose name appears in the preliminary list or who has made a claim for the inclusion of his name in the list may, while the 14 days following the publication of the list, i.e. from 18 to 31st October, by notice in writing to the Electoral Officer on a form obtained at the office of the Electoral Officer object to the inclusion in the list of the name of any other person, provided that a copy of such notice within the same period of 14 days be delivered to the person whose name is objected to.

13. After 31 October the Chief Electoral Officer will appoint Review Officers to revise in open Court the preliminary list on the dates and at the times and places specified in the notice accompanying the preliminary list on its first publication in each Ward.

14. The Review Officers will by regulation 14(1) complete the revision of the preliminary list by 10 November, and will deliver it settled and signed by that date to the Electoral Officer.

15. The revised list will constitute the register of electors, and anyone whose name is not included in the register will not be entitled to vote.
