Atako Ise Ero Radio **THREAT OF STRIKE** Nilu Oyinbo



The following statement is issued on the authority of the Federal Government.

1. The Trades Union Congress have announced that they propose to call upon their member unions, including those which represent Government staff, to come out on strike from or about the 1st of November, 1959, in connection with the Congress's demand for an interim award (on account of the general review of salaries and wages now proceeding) of 50% for daily paid workers and 3% for junior salaried staff, effective from 1st of February, 1959.

2. The Federal Government is fully aware of the uneasiness felt by its established and unestablished employees about the present cost of living. As this matter affects officers and workers of the Federal Government stationed in localities throughout Nigeria, and represented by a wide variety of unions and staff associations a Commission for the review of wages and salaries has been appointed and will shortly make recommendations to the Federal Government and those Regional Governments which are associated with it in the review. In order to alleviate existing hardships, an interim award equal to 100% of the current basic rates of salaries and wages has been granted to salaries officers on the long scales (except certain highly-paid contract employees) and to daily paid workers. The purpose of the interim award is to grant interim relief, and award is therefore effective from the 1st September, 1959, until the Commission's recommendations have been received. Its decision on them is made by the Government. In view of the statistics available, and in view of the purpose for which the reviewing Commission has been appointed, the Federal Government considers both the amount and the effective date of its interim award to be eminently just and reasonable.

3. The Executive body of the Trade Union Congress was informed at all stages of Government's intentions with regard to the review of salaries and wages, and their goodwill was sought. The Congress was also informed that an interim award was contemplated and, since it had expressed views on this subject, was invited to explain its views. At all stages it has been made clear to the Congress however that, because the increased cost of living is a matter which affects all workers and all the unions which represent them, neither the general wage and salary levels which will result from the review nor the amount of the interim award can be made open to negotiation. Nor, even if negotiation were possible, could the Federal Government accept the Trade Union Congress as a competent body to negotiate on behalf of the Federal Government employees. In all matters properly subject to negotiation, the Federal Government will continue to act through the Whitley Councils which are the established joint negotiating bodies in respect of Civil Service conditions. The proper role of the Congress, in the view of the Federal Government is that of adviser and guide to its constituent unions. It should not usurp the functions which are proper to the unions themselves.

4. With regard to the Trades Union Congress's threat of strike action on or after the 1st of November, all employees of the Federal Government are reminded that to come out on strike and to attempt thus to halt or dislocate the operations of the Government is a serious breach of discipline. Any who may contemplate going on strike, whatever kind of strike it may be, should understand clearly that -

- (a) they will receive no pay while they are on strike; and
- (b) they will be liable to dismissal and to the forfeiture of any pension, retiring allowance or gratuity for which they might otherwise be eligible.

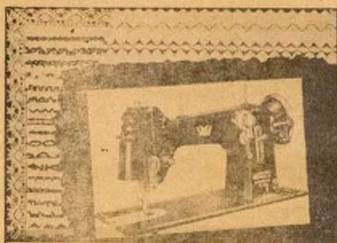

Powers Of Polling Agents

Under Regulation 63 of the Electoral Regulations each candidate is allowed to appoint two persons to attend at each polling station in the constituency for which he is a candidate and these persons are referred to as Polling Agents.

The Regulation also provides that the powers of Polling Agents may be laid down by the Electoral Commission. The Commission has decided that no further powers should be given to Polling Agents in addition to those which are already conferred upon them by the Regulations.

These powers are -

1. To be present in the polling station throughout the hours of poll (Regulations 63 and 85).
2. To look at the ballot boxes inside the polling station immediately before they are locked and sealed, to see that they are empty, that they are duly marked with the name and symbol of the candidate and that his photograph is displayed, if it has been provided, and to see that they are fixed inside the voting compartment in accordance with the Regulations before polling starts (Regulation 66 (3)).
3. To watch the polling officer opening the sealed packets of ballot papers and to inspect them (Regulation 66 (3)).
4. To see each ballot paper to be marked with the official mark before it is issued to the voter (Regulation 68 (a)).
5. To require a polling officer to put to a voter applying for a ballot paper the following questions :
(a) "Are you the person who is on the Register of Electors as follows, ?"
(b) "Have you already voted at the present Election at this or any other polling station ?"

(REGULATION 69)

6. To declare to the Presiding Officer at any time when a person applies for a ballot paper or after he has applied but before he has left the polling station that he has reasonable cause to believe that the applicant has committed an offence of impersonation. If a Polling Agent makes such a declaration, he must sign an undertaking in writing to substantiate the charge in a Court of Law and the Presiding Officer may then order a Police Officer to arrest the applicant. (REGULATION 81)

7. To be present after the close of poll while the Presiding Officer seals the ballot boxes and makes up the packets referred to in Regulation 89 (REGULATION 89 (1))

8. To verify the ballot papers account prepared by the Presiding Officer. If a Polling Agent does this, he must then sign the account. (REGULATION 89 (4))

A candidate has all the powers of a Polling Agent. (REGULATION 63)

The Electoral Commission wish to make the following two points quite clear:-

(a) Although a Polling Agent has the rights set out above, he is not entitled to interfere with the conduct of the poll and if he misconducts himself or fail to obey a lawful order given by the Presiding Officer, the Presiding Officer has been instructed to order him to be removed from the polling station.

(b) Although Polling Agents have the RIGHT to be present, their presence is not ESSENTIAL and in no circumstances will the conduct of proceedings be delayed because a Polling Agent is not present. If a Polling Agent is absent before the opening of a polling station when the Presiding Officer is sealing and locking the ballot boxes and opening the sealed packets of ballot papers, the Presiding Officer will not wait for him. If a polling Agent is absent at the close of poll when the Presiding Officer is ready to seal the ballot boxes and the other packets referred to in the Regulations, the Presiding Officer will proceed to do this without him.
