American Believes Peaceful Negotiation Can End War

WASHINGTON—It is fundamental policy of the United Nations that international disputes should be settled by peaceful negotiation, according to the secretary of State, Mr. Dean Acheson.

He concluded testimony last week before the House of Representatives Foreign Affairs Committee, which is considering President Truman's recommendations for an \$8,500,000,000 Mutual Security Programme of military and economic aid to other countries, by responding to a question from Representative George H. Mahon of Texas.

Mr. Acheson was asked a number of questions about developments in the Far East. In his replies, the secretary reiterated that the United States firmly holds the position that Communist China should not be admitted to the United Nations and that those who claim to represent a nation should not be allowed to shoot their way into the world organization.

Another representative asked Mr. Acheson about ending obligations for rehabilitating Korea in the event of a truce. The Secretary said the obligation is that of the United Nations, which undertook to do all it could to rehabilitate Korea.

Speaking of the threat presented by the Soviet Union, he said the defense programme must continue to the point where the outbreak of additional aggression becomes very impracticable. He said that the present great disparity of power in the world makes it seem to one nation that negotiations are unnecessary, but the United States disagrees.

In answer to another question, Mr. Acheson said he opposed the idea of terminating the Economic Cooperation Administration and the setting up of an entirely new agency to handle the proposed Mutual Security Programme. The loss of ECA personnel and other important officials involved during the transition period, he added, would offset the advantages of doing away with ECA. However he said the matter is one for the judgment of Congress.

Western House Of Assembly

The next meeting of the Western House of Assembly opens on the 12th of July on Tuesday, the 17th of July, in the Assembly Hall, Ibadan.

A limited number of seats are available for persons wishing to attend as spectators. Tickets may be obtained at the Regional Press and Information Office in Ibadan Road, Ibadan, between the hours of 8.30 a.m. and 3.15 p.m. on the 12th, 13th, 14th and 15th of July. No charge is made for tickets of admission.

Farmers Bank Wins Long Drawn Suit

The Supreme Court lagged in favour of Mr. A. S. O. Coker, the Director Farmers Bank Ltd. The contestants were the former managing director of the bank and Mr. A. S. O. Coker the present Chairman of the board of Directors.

Mr. A. S. O. Coker on behalf of the Farmers Bank sued Dozima asking for an injunction that he was not a director.

It was related that Dozima had been a member of the board because he had no share certificate. Mr. Dozima claimed for an injunction against Mr. Coker was dismissed.

The case came before His Honour Mr Justice V.R. Barnes.
