

PRESS RELEASE

Information has been received in the office of the Lagos Town Council relating to the closure of the Cinema "Odeon" located at 10, Odeon Street, Lagos.

The Lagos Town Council has issued the sign of PROVOC as notice to the owner of the Cinema "Odeon" that it must close down or suspend some weeks ago. The Manager of the Cinema "Odeon" and his wife were summoned on the 2nd of December, 1957. The Manager informed the Town Clerk that he was then working as the Chief Education Officer, Lagos Town Council. It was not his appointment to make arrangements for the closure of this cinema nor had any arrangement been made at time of his appointment. The responsibility of education lies with the Lagos Town Council.

MOVIE SCREEN LICENSING BOARD

In view of the decision of the Council not to renew the license of the Cinema "Odeon" it is requested that the Secretary of the Lagos Town Council to withdraw from the issuance of licenses in various parts of the town and districts in uncontrolled areas. It would appear that majority of the exhibitors are already under the impression that the Lagos Town Council is responsible for the closure of the Cinema "Odeon". The Council has directed us to make it abundantly clear that although no sympathies with the current cinemas which have been removed around the City centre, in view of the responsibility of the Lagos Town Council to ensure that all public places remain decent for some while longer.

The closure of the mentioned Cinema "Odeon" was no decision of the Lagos Town Council, the Lagos Town Council being the Movie Screen Licensing Board which is a statutory body established by the Federal Government under the Cinematograph Act. The decision of the Council is dictated by the State Government of Lagos. It is understood that the Lagos Town Council has now modified its original decision in respect of these points.


