## Carter Bridge Damaged

During the early hours of Thursday, September 6th, a number of heavy barges in Lagos Harbour broke adrift and were carried by the current against Carter Bridge with great violence.

Some of the steel piers which support the Bridge have been seriously damaged and the Director of Public Works has ordered the reduction of speed of traffic to 20 miles an hour. It has also been necessary to reduce the effective width of the bridge at the place where it is damaged.

Arrangements have already been made with Messrs Dorman Long & Co Ltd., the contractors who built the new Cross River Bridge, for the replacement of corroded steelwork in Carter Bridge, and they will also be asked to undertake the repairs now required. The work will be begun before the end of the year.



In making the announcement Mr. Kalejaiye said that this is an historic moment in the development of Consumer Cooperation in Nigeria. He pointed out that by returning profits earned over and above operating expenses to the members and patrons of the Society one of the cardinal principles of Cooperation was being exercised. "This Proves", he said, "that consumer cooperation has come of age in Nigeria, it also proves beyond any doubt that Nigerians can work together, efficiently to solve their economic problems.


