

West African Examinations Council
University of London General
Certificate of Education
EXAMINATION. 1954.**

The University has agreed that candidates who took the General Certificate of Education Examination, 1954, and who were successful at the Cambridge School Certificate Examination, 1953, may receive certificates for examinations in subjects in which they gained credits at the General Certificate of Education Examination, even if those subjects are less than four in number.

2. Candidates eligible for this concession should write to the Registrar, West African Examinations Council, Taba stating their 1953 Cambridge School Certificate and their 1954 General Certificate of Education examination numbers and centres. Letters must reach the Registrar by 20th August, 1954.

3. Candidates eligible for the General Certificate of Education Examination, subjects in which they gained credits at the Cambridge School Certificate Examination, 1953, ARE NOT ELIGIBLE TO RECEIVE FEES REFUNDS.

4. The University is unable to grant a similar concession to candidates for earlier General Certificate of Education Examinations who gained the School Certificate in the December before they took the General Certificate of Education and who passed the General Certificate of Education Examination in less than four subjects.
