### EIGHT NEGROES ON JURY TO HEAR DUBOIS CASE

WASHINGTON-Twelve men and women were chosen last week as jurors for the trial of Dr. W. E. B. Dubois and four other sections and friends who took part in the Peace Information Centres who are charged with failure to register under the Foreign Agents Registration Act.

The panel of jurors, which convened on (November 13) was composed of eight Negroes and four white persons. They were selected from a panel of more than 125 persons from all walks of life.

Selection of jurors took place at the court room of Federal Judge Mahlon F. McGuire, U.S. Attorneys, outlining charges against the Peace Information Centres, and by defendant.

The prosecution then proceeded to address questions to prospective jurors. Defendants' attorneys, after a recess, addressed jurors with questions and a set of questions were designed to eliminate any jurors hostile to either case for defense or prosecution.

The attorneys asked jurors such questions as: "Have you ever opposed Federal Anti-Poll Tax Act, Federal Fair Employment Act, and Federal Anti-Lynching Act?" They asked prospective jurors if they sympathized with racial discrimination against Negroes in housing, transportation, employment and other fields. The defense also asked if jurors had relatives in United States armed forces. Eighteen persons replied in affirmative. These persons were then asked if these relationships would in any way prejudice their verdict. None replied in affirmative.
