



Until further notice the following alterations in passenger train services between Lagos Terminus and Ibadan are effective:

(a) LAGOS — ABEOKUTA

The Local train which at present departs Lagos Terminus (except Sundays) at 6.05 a.m. for Abeokuta will, in future, depart at 7 a.m. The train will terminate at Ishewas and all passengers travelling beyond Ishewas will transfer to another train i.e. Lagos — Offa train which departs from Ishewas at 11.05 a.m.

(b) LAGOS — OFFA

Through departure time of the 8 a.m. train from Lagos Terminus to Offa and her arrival at Ibadan remain unaltered, few changes have been made between Ikorodu and Ewebi Road.

(c) LAGOS — IDOGO

The 7 a.m. Local train from Lagos Terminus to Idogo (daily) will leave at 6.05 a.m. and arrive Idogo at 10.37 a.m.

(d) ABEOKUTA — LAGOS TERMINUS

A local train to Lagos Terminus 6.50 a.m. local train (except Sundays) will leave at 6.30 a.m. Arrival time at Lagos Terminus remains unchanged.

(e) OFFA — LAGOS TERMINUS

7.30 a.m. Offa to Lagos Terminus local train (Sundays only) will maintain the present timing as far as Ifaw Junction. Departure from Ifaw Junction will be later and to arrive Lagos Terminus at 8.17 p.m. These changes in train timings are regretted, but important engineering works on the track have made them necessary.
