CHRIST'S DEATH WARRANT

"A DOCUMENT which archaeologists believe to be the Roman
dictary order under which Jesus Christ was tried has

these people. These prophets are not to be interfered with under
the Roman law except when their teachings are of such nature
to cause disturbances among the people. In such cases they
are to be effectively suppressed."

"It is particularly desirable that these prophet's be not
allowed to interfere with the collection of taxes or with any
other political affairs."

"The edict was signed by Augustus Caesar."


