Bravo! to Mr. J. M. Stuart Young for his latest contribution on Public Speaking in the latest issue of *The African Messenger*.

"To start with" says Mr. Young "wine is not poured from a water-butt. Gold is not discovered near to iron-ore.....The valuable material of Thought must be at the command of the spirit" etc.

Bon! as the Frenchman would say, so much for those whose spirits command the material of Thought—those who know and know they know—but what about those who have no natural talent for it, I mean those who after all honest efforts could not come up to the mark? And these alike, certainly, would have occasion to speak in public sometimes or the other. "It is not expected" says An Oxford M.A. "that any one will inflict a speech who is incapable of making one." What alternative hints should this class of people take?


