### Man of the Week.

#### THE REV. AMOS NATHANIEL COLE, WESLEYAN NATIVE MINISTER.

Born 1852; was at one time a Government Official, entered the ministry, 1891; laboured in almost all the circuits in the districts; appointed Superintendent of Olowogbobo Circuit, 1904-1914; transferred as Superintendent to the Faji Circuit, 1914, where he still labours; was appointed to preach the Centenary Sermon of the Society, 1913; is the only native minister of his persuasion, honoured to deliver an Ordination Charge on two occasions at Lagos; is at present the Senior Native Minister in active service in the Lagos district. Was requested to deliver an Address at the Memorial Service of the late Professor S. M. Harden, 1919; is an eloquent preacher and a ripe scholar. Was presented with a Congratulatory Address and a Purse by his Church (Wesleyan Timbu) on his attaining his 70th Birthday in October last, June 18, 1923.


