#### REX versus DURO DELPHONSO

Coroner's Jury at the Inquest held on Wednesday last in the Police Court Tinubu Square recorded their Verdict to the effect that Barrister M. Abayomi died on Saturday the 25th instant of Gun-shot wounds being the result of the revolver fired at him at close quarters by Duro Delphonso on the day in question.

Three Witnesses were examined Viz.

Sergeant Robert Banjo Dr. R. F. O'Keefe Mr. J. Bagan Benjamin c.e.

The Doctor produced the shot extracted from the body of the deceased. Assistant Superintendent T. I. Kester prosecuted on behalf of the Crown. The accused still lying ill in the Prison Hospital was unable to be present, with the result that the Inquest was adjourned *sine die*.

My protest, three months ago, against the wholesale importation of negro artists into London, when 2,000 English actors and actresses were unemployed, was followed by my being bitterly denounced, in America, by Marcus Garvey, a negro who calls himself "President-General of the Universal Negro Improvement Association," "England's Christian love is a farce," he said. "In the tropics, when he wants to rob our wealth, mineral and agriculture, the Englishman brings us a Bible and a hymn-book, and tells us how much he loves us, and that we are children of one common Father, and points the hope of a glorious day, when all of us will meet around the Throne of Heaven. But, when we meet him on his own soil, he tells us a different tale. After he has robbed our diamond mines and stripped Africa of its wealth and taken it to England, he tells us the black man is not wanted there.

Then, asking for donations "to help on the work," he said: "We may not hope to make good in the music-halls of London; but we look forward to the day when we negroes will entertain ourselves in our own theatres, music-halls, and opera-houses in our homeland, Africa."

The *Negro World*, Garvey's organ, published in New York, breathed hatred of England. Last week, Marcus Garvey was sent to prison for five years by an American judge for swindling his brother and sister negroes by inducing them to invest in a fraudulent shipping company. So I shall be saved from his attacks for some time.

SOUZA DE IZIDRO EGIDIO.

Mercantile Clerk aged 46; is younger brother of Simons Izidro De Souza; born at Lagos September, 1877; educated St. Gregory's Grammar School (R.C.) Lagos joined the British African steam Navigation Co, as Clerk under Mr. George W. Neville a European, the Agent of both firms 1891; was Clerk to Lloyd's Agents, was in charge of the Forcados Shipping Labour Bazaar, 1905; appointed Jubilee Treasurer, (honorary) in connection with the celebrations of the Golden Jubilee of the Roman Catholic Mission in Nigeria, 1919; was a foundation member of the Catholic Friendly Society, No 3616; founded in Lagos 1903; successfully passed through the dissenting offices of that Society to the entire satisfaction of its members, had the unique distinction of the title of Distinguished Past present bestowed on him by his brother officers and members of the Society; was in the employ of Messrs Elder Dempster & Co, Ltd, up to the time of his death; appointed Assistant Secretary to the National Congress of British West Africa, Lagos Beach, 1920; possessed a costly library; was energetic, patriotic and social; died at his residence, 12 Taiwo Street on 29th August, 1923 after a lingering illness.
