

SHINGLE, EGERTON JOSEPH

Barrister-at-Law, and planter aged 61 educated at Sierra Leone C.M.S. Grammar School, Wesleyan Boys' High School, Gambia; Fourah Bay College, Sierra Leone; and at Christ Church College (Oxford, England) called to the Bar April, 1888 came to Lagos 12th September, 1892 successfully raised subscriptions for and on behalf of Prince Eleko in connection with the overseas comforts fund, 1917, for oratory and high legal attainments is second to none, is nick-named "The Lion of the Bar" on account of his legal accomplishment as a defending counsel, is *ex plae infra*, lost his eldest son Ladiipo in the war 1918, took leading part in Eleko's reinstatement 1919; elected to the Lagos Town Council 1923; returned to the Legislative Council of Nigeria according to the new Instrument of Government relative to the Franchise granted by His Excellency The Governor Sir Hugh Clifford G.C.M.G. J by the Nigerian National Democratic Party of which he is the President, September 20, 1923.

MOORE, OLAWOLU ERIC

Barrister-at-Law aged 45, born in Abeokuta, Nov. 1878 educated C.M.S. Grammar school, Lagos, 1891-1894; and subsequently in the Sierra Leone Grammar School, (C.M.S.) 1895 as student in Monkton Combe College (Bath) England, studied Law in Middle Temple, London, called to the Bar 1902, Married Miss Ada Vaughan, 15th September 1904, lost his father the Hon: C. B. Moore in Abeokuta 1906, appointed member of the Legislative Council, Lagos, 23rd February 1917, was member of the Commission of Enquiry appointed by the Government in respect of the Igha Unrest 1918 is an embodiment of gentility, past master in forensic lore; kind, liberal and patriotic to the core; the "Father" of Municipal Elective Representation in Nigeria; returned to the Legislative Council of Nigeria, by the Nigerian National Democratic Party of which he is the Vice President, under the elective system, September 20, 1923.

JONES, ADENIYI CRISPIN CURTIS

Medical Practitioner appointed Medical officer, Lagos 28th September, 1904; arrived in the Colony 4th October 1904 was placed under the late Dr. C. Jenkins Lumpkin in Massey Street Dispensary, subsequently was sent to Epe, Ijebu Ode, and Badagry, left the Civil Service 1913 has contributed a series of stirring articles on "Health of Infants" in the "African Messenger" under the pseudonym *Embryo Medicus*; has built out of pocket and opened an Hospital for the care of suffering humanity; honorary Physician to Prince Eleko and some of The White Cap Chiefs of Lagos, returned to the Legislative Council by the Nigerian National Democratic Party, of which he is the Vice President, September 20, 1923.
